The Pastor's Message

The Future of St. Luke's

Since I began my role as Interim Pastor at St. Luke's, the Church Council has shown a strong interest in the future of our Church, which is very appropriate. Recently, this topic has been approached from a different angle. There may be upcoming discussions by the Church Council regarding the Allentown Collaborative Ministries and the Northeastern Pennsylvania Synod. I want to provide an overview of what is happening.

Before proceeding, I want to emphasize that this discussion is still in its early stages. Nothing will happen in the immediate future; I am not going anywhere. Any potential decisions will involve the entire congregation before any choices are made or acted upon.

The term you may hear discussed is "6-2-6-1 Ministry Communities." This is often referred to as the 6-2-6-1 Plan, but that can be misleading since it is not a rigid plan. Instead, it serves as a flexible framework for congregations that wish to collaborate in ministry efforts. Congregations looking to work together can create arrangements that best suit their needs.

"6-2-6-1 Ministry Communities" refers to a collaborative group of six congregations, two pastors, six licensed lay ministers, and one deacon. The purpose of this initiative is for these congregations and individuals to work together in ministry. A key motivation for this concept is the significant shortage of ordained pastors within the synod and the Evangelical Lutheran Church in America (ELCA). Currently, ELCA seminaries are graduating enough pastoral candidates to fill only about 30% of the funded pastoral vacancies nationwide. This shortage has a notable impact on our synod. So, where does St. Luke's stand regarding its future? I believe that St. Luke's has been very active since I arrived. The Welcome and Witness Committee, under Chairperson Lynn Weaver, began holding meetings in 2022 that involved the entire congregation. This initiative resulted in the successful Coffee Hour event. The Committee also proposed several other strategies, including a plan focused on increasing worship service attendance. This strategy aimed to double attendance in two years and quintuple it in five years. The Church Council reviewed and approved this proposal.

Furthermore, the Welcome and Witness Committee suggested the reinstatement of an Education Hour from 9:00 to 10:00 A.M. on Sundays. Although implementing this took some time, it is now successfully functioning. The congregation initially faced challenges due to the unexpected loss of our Parish Administrator, Leslie Talago, which temporarily delayed many activities. However, St. Luke's has recently hired Camille Campbell as the new Administrative Assistant to fill that position.

Additionally, the Church created a new role of Outreach Coordinator, appointing Pastor Dr. Genie Watson to this position. Pastor Genie has been quite active in her role. Overall, I would say that St. Luke's has been very engaged and proactive in shaping its future.

St. Luke's has been actively engaged in the city of Allentown in a new way. In 2022, St. Luke's proposed that Lutheran Churches in Allentown collaborate to initiate a Mid-Week Lenten Gathering in 2023. This proposal led to the formation of Allentown Collaborative Ministries (ACM). Initially, the ACM involved six Lutheran Churches in Allentown, but it has since been expanded to include several non-Lutheran congregations.

What is the role of Allentown Collaborative Ministries (ACM) in the discussion of a "6-2-6-1" plan? For the past two years, pastors or representatives from six Lutheran congregations have been meeting monthly. Recently, they have begun to actively explore the possibility of ACM participating in discussions regarding a "6-2-6-1" plan in Allentown. They have asked me about inviting St. Luke's to join this discussion.

What is my role, as an Interim Pastor, in such collaborative discussions about a "6-2-6-1" plan? I have communicated to the Collaborative and the St. Luke's Church Council that I should not be directly involved in making decisions regarding this matter, as such decisions belong to the Council and ultimately to the congregation. I can answer questions and assist, but I have encouraged the Collaborative to extend an invitation directly to the St. Luke's Church Council. They understood my position and sent an official invitation to the Council, which was considered for the first time at the Church Council meeting on November 14.

The Council had requested a meeting with the Synod regarding the future of St. Luke's. This meeting occurred on October 15 and included Pastor Jean Huber, the Assistant to Bishop Christopher deForest, who oversees congregations in Lehigh County. Following the discussion with Pastor Huber, the Council held a brief conversation about the next steps during the Council meeting on November 14.

This discussion is still in its early stages, and there is nothing substantial to report except that a preliminary conversation has just begun. However, since news travels quickly, I want to provide some basic information to prevent misunderstandings. I also want to clarify my role in this matter. I neither support nor oppose the discussion or potential adoption of a "6-2-6-1" type of plan. I believe this decision ultimately belongs to the Council. As your Interim Pastor, I will assist them in their work, but I will not take a central role in the discussions regarding any actions.

On a very different topic, we are approaching the celebration of a hugely important event in the history of the world, the birth of our Savior, Jesus Christ! Therefore, I want to extend the best wishes of my wife, Barbara, and myself to all of you. We want to wish you all a very Merry and Blessed Christmas!






